	<b>Where am I covered?</b>
<ul style="list-style-type: none"> <li data-bbox="76 571 102 607">✓</li> </ul>	<p>We will provide the minimum insurance needed by the relevant law to allow you to use your vehicle in the European Union, Andorra, Iceland, Norway, Serbia or Switzerland (including Liechtenstein).</p> <p>We will provide the cover shown on your schedule in these countries for up to 90 days per trip, for a maximum of 180 days per policy period.</p> <p>Your permanent home must be in Great Britain, Northern Ireland, the Channel Islands or the Isle of Man and your visit to these countries must be temporary.</p> <p>Please note if travelling outside the United Kingdom you will need to request a Green Card from your broker.</p>
	<b>What are my obligations?</b>

If you have failed to give us complete and accurate information, this could lead to us changing the terms of your policy, refusing your claim or the insurance not being valid.</p> <p><b>In the event of a claim or possible claim:</b> You will need to pay the agreed excess as shown in your schedule. You must notify the Rescue Control Centre immediately of a breakdown.</p> <p>You must not admit to, negotiate on or refuse any claim unless you have our permission.</p> <p>You must tell us immediately about any changes to the information you have already provided. Please contact your broker if you are not sure if information is relevant. If you don't tell us about relevant changes, your insurance may not cover you fully, or at all.</p>

	<b>When does the cover start and end?</b>

	<b>How do I cancel the contract?</b>
<ul style="list-style-type: none"> <li data-bbox="76 1720 102 1756">-</li> <li data-bbox="76 1783 102 1818">-</li> </ul>	<p>You may cancel the insurance at any time by informing your broker.</p> <p>If you change your mind about this insurance, you must advise us within 14 days of the start date. Provided your vehicle has not been subject of a claim(s), we will refund a proportional amount of premium based on the number of days remaining on your policy. The minimum amount that will be retained by ERS will be £25 (plus insurance premium tax (IPT) where applicable).</p>
