What is this type of insurance?

Accidental Damage, Fire & Theft cover – You are covered for loss or damage caused by accidental damage, fire and theft.

✓	<p>Loss of or damage to your vehicle as shown in your schedule for accidental damage, fire and theft. We will either cover your costs to repair, pay a cash amount to replace or replace the lost or damaged item. The most we will pay for the loss of or damage to your vehicle is up to the value shown on your schedule.</p>	✗	<p>Your policy excesses as shown in policy documentation.</p> <p>✗ Compensation for not being able to use your vehicle.</p> <p>✗ Damage or loss due to wear and tear, failures, breakdowns or breakages of mechanical, electrical or computer equipment.</p> <p>✗ Loss or damage between October and April if water and internal sanitary systems are not drained while in storage.</p> <p>✗ Damage to your tyres unless caused by an accident to your motorhome.</p> <p>✗ Any accessories not permanently attached to your vehicle.</p> <p>✗ Loss or damage to your vehicle as a result of deception.</p> <p>✗ Loss or damage by theft or attempted theft if left unlocked or windows/roof panel/skylight left open or the keys left in or on your vehicle.</p> <p>✗ Loss of damage to your vehicle taken without consent by a member of your immediate family or a person living in your home, unless that person is convicted of theft.</p> <p>✗ Loss of fuel or damage caused by incorrect fuel/additive being used.</p> <p>✗ Loss of food and drink.</p> <p>✗ Loss or damage covered by another insurance policy.</p> <p>N.B. 	Are there any restrictions on cover?
	Endorsements may apply to your policy, these will be shown in your policy documents.
	If a claim is made which you or anyone acting on your behalf knows is false, fraudulent, exaggerated, or provides false or stolen documents to support a claim we will not pay the claim and cover under this insurance will end.
	Where am I covered?
	We will provide the cover for Great Britain, Northern Ireland, the Channel Islands or the Isle of Man.
	What are my obligations?
	<p>Your premium is based on the information you gave at the start of the insurance and when it is renewed. If you have failed to give us complete and accurate information, this could lead to us changing the terms of your policy, refusing your claim or the insurance not being valid.</p> <p>In the event of a claim or possible claim: You will need to pay the agreed excess as shown in your schedule. You must notify us within 72 hours of the incident happening.</p> <p>You must not admit to, negotiate on or refuse any claim unless you have our permission.</p> <p>You must tell us immediately about any changes to the information you have already provided. Please contact your broker if you are not sure if information is relevant. If you don't tell us about relevant changes, your insurance may not cover you fully, or at all.</p>
	When and how do I pay?
	For full details of when and how you pay, you need to contact your broker directly.
	When does the cover start and end?
	Your insurance is a 12 month contract which may be renewed each year. Renewal will be subject to the terms and conditions that apply at the time of renewal.
	Your insurance cover start and end dates will be shown on your policy schedule and certificate of motor insurance.
	How do I cancel the contract?
	You may cancel the insurance at any time by informing your broker.
	If you change your mind about this insurance, you must advise us within 14 days of the start date. Provided your vehicle has not been subject of a claim(s), we will refund a proportional amount of premium based on the number of days remaining on your policy. The minimum amount that will be retained by ERS will be £25 (plus insurance premium tax (IPT) where applicable).
	Cancellation after 14 days from the start date will be charged in line with the short term period rates as shown in your policy wording.
