	What are my obligations?

-	Your premium is based on the information you gave at the start of the insurance and when it is renewed. If you have failed to give us complete and accurate information, this could lead to us changing the terms of your policy, refusing your claim(s) or the insurance not being valid.	
-	In the event of a claim(s) or possible claim(s): You will need to pay the agreed excess as shown in your policy documentation.	
-	Comprehensive cover for driving other cars excess: We will apply the highest excess applicable to any vehicle as shown on your schedule.	
-	Windscreen excesses: If your windscreen is replaced by our approved supplier, you must pay the first £100 of any claim(s). If your windscreen is repaired by our approved supplier, you must pay the first £10 of any claim(s). If your windscreen is repaired or replaced by any other company, you must pay the first £125 of any claim(s).	
-	You must not admit to, negotiate on or refuse any claim(s) unless you have our permission.

-	If you change your mind about this insurance, you must advise us within 14 days of the start date. Provided your vehicle has not been subject of a claim(s), we will refund a proportional amount of premium based on the number of days remaining on your policy. The minimum amount that will be retained by ERS will be £50 (plus insurance premium tax (IPT) where applicable).
