Please contact your broker if you are not sure if information is relevant. If you don't tell us about relevant changes, your insurance may not cover you fully, or at all. | |

|  | When does the cover start and end? |
| <ul style="list-style-type: none"> - Renewal will be subject to the terms and conditions that apply at the time of renewal. - Your insurance cover start and end dates will be shown on your policy schedule and certificate of motor insurance. | |
|  | How do I cancel the contract? |
| <ul style="list-style-type: none"> - You may cancel the insurance at any time by informing your broker. - If you change your mind about this insurance, you must advise us within 14 days of the start date. Provided your vehicle has not been subject of a claim(s), we will refund a proportional amount of premium based on the number of days remaining on your policy. The minimum amount that will be retained by ERS will be £50 (plus insurance premium tax (IPT) where applicable). | |
