	Where am I covered?
	<p>We will provide the minimum insurance needed by the relevant law to allow you to use your vehicle in the European Union, Andorra, Iceland, Norway, Serbia or Switzerland (including Liechtenstein).</p> <p>We will provide the cover shown on your schedule in these countries for up to 30 days per trip.</p> <p>Your permanent home must be in Great Britain, Northern Ireland, the Channel Islands or the Isle of Man and your visit to these countries must be temporary.</p> <p>We can provide full policy cover when you travel abroad or additional countries for which we have agreed to.</p>

Renewal will be subject to the terms and conditions that apply at the time of renewal.</p> <p>Your insurance cover start and end dates will be shown on your policy schedule and certificate of motor insurance.</p>
	How do I cancel the contract?
<ul style="list-style-type: none"> <li data-bbox="76 1657 105 1684">- <li data-bbox="76 1720 105 1747">- 	<p>You may cancel the insurance at any time by informing your broker.</p> <p>If you change your mind about this insurance, you must advise us within 14 days of the start date. Provided your vehicle has not been subject of a claim(s), we will refund a proportional amount of premium based on the number of days remaining on your policy. The minimum amount that will be retained by ERS will be £25 (plus insurance premium tax (IPT) where applicable).</p>
