Comprehensive cover – You are covered for loss or damage caused by accidental damage, fire, theft and third party liability cover.

<ul style="list-style-type: none"> ✓ ✓ ✓ ✓ ✓ ✓ ✓ 	<p>Whilst driving your vehicle you will be covered for any one claim or claims arising out of one incident following:</p> <p>Property damage up to £5,000,000; Property damage costs/expenses up to £5,000,000; Legal costs up to £35,000; Prosecutions against Health & Safety up to £1,000,000.</p> <p>Loss of or damage to your vehicle as shown in your schedule for accidental damage, fire and theft. We will either cover your costs to repair, pay a cash amount to replace or replace the lost or damaged item. The most we will pay for the loss of or damage to your vehicle is up to the value shown on your schedule.</p> <p>Damage to your windscreen or windows is provided.</p> <p>Loss of keys and replacing locks for your vehicle if lost or stolen and have not been recovered up to £300, provided you let the police know and the address where the vehicle is kept would be known to any person who has your keys or lock transponder.</p> <p>Medical expenses for you or anyone who is injured while they are in your vehicle as a result of an accident up to £200.</p> <p>Personal Accident cover for you, your spouse or civil partner, if involved in an accident & within three months of that accident it is the only cause of death or injury. !	Endorsements may apply to your policy, these will be shown in your policy documents.
!	If a claim is made which you or anyone acting on your behalf knows is false, fraudulent, exaggerated, or provides false or stolen documents to support a claim we will not pay the claim and cover under this insurance will end.
	Where am I covered?
✓	<p>We will provide the minimum insurance needed by the relevant law for up to 30 days per trip while you are using your vehicle in the European Union, Andorra, Iceland, Norway, Serbia or Switzerland (including Liechtenstein).</p> <p>Your permanent home must be in Great Britain, Northern Ireland, the Channel Islands or the Isle of Man and your visit to these countries must be temporary.</p> <p>We can provide full policy cover when you travel abroad or additional countries for which we have agreed to.</p>
	What are my obligations?
-	Your premium is based on the information you gave at the start of the insurance and when it is renewed. If you have failed to give us complete and accurate information, this could lead to us changing the terms of your policy, refusing your claim or the insurance not being valid.
-	<p>In the event of a claim or possible claim: You will need to pay the agreed excess as shown in your schedule. If you report the incident to ERS after 48 hours of occurring an additional £500 excess may be applicable. If you report the incident to ERS within 24 hours of occurring we will discount your excess by £100.</p>
-	<p>Windscreen excesses: If your windscreen is replaced by our approved supplier, you must pay the first £75 of any claim. If your windscreen is repaired by our approved supplier, you must pay the first £10 of any claim. If your windscreen is repaired or replaced by any other company, you must pay the first £125 of any claim.</p>
-	You must not admit to, negotiate on or refuse any claim unless you have our permission.
-	You must tell us immediately about any changes to the information you have already provided. Please contact your broker if you are not sure if information is relevant. If you don't tell us about relevant changes, your insurance may not cover you fully, or at all.
	When and how do I pay?
-	For full details of when and how you pay, you need to contact your broker directly.
	When does the cover start and end?
-	Your insurance is a 12 month contract which may be renewed each year. Renewal will be subject to the terms and conditions that apply at the time of renewal.
-	Your insurance cover start and end dates will be shown on your policy schedule and certificate of motor insurance.
	How do I cancel the contract?
-	You may cancel the insurance at any time by informing your broker.
-	If you change your mind about this insurance, you must advise us within 14 days of the start date. Provided your vehicle has not been subject of a claim, we will make a charge equal to the period of cover you have had, but this charge will be subject to a minimum amount of £25 plus Insurance Premium Tax.
-	If you cancel your policy outside the 14 day period then provided your vehicle has not been subject of a claim, we will refund the proportional (pro-rata) amount of the premium which applies to the remaining period of insurance, less a premium charge of £75 (subject to insurance premium tax (IPT) where applicable).
